

**RESOLUTION NO. R-189-2024**

**RESOLUTION ESTABLISHING REFUSE, RECYCLING AND YARD WASTE RATES**  
**EFFECTIVE JANUARY 1, 2025**

**WHEREAS**, pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et seq.*, the Village of Bensenville (the “*Village*”) provides the refuse and recycling services to its residents.

**WHEREAS**, the Illinois Municipal Code at Division 139 grants the Village the authority to charge its inhabitants a reasonable compensation for the use of refuse services and to establish rates for that purpose; and

**WHEREAS**, the Village of Bensenville has established a refuse and recycling service contract with the Allied (Republic Services) for the period of January 1, 2019 to December 31, 2023; and

**WHEREAS**, the refuse contract provides for an annual increase in costs of 4% starting January 1, 2025; and

**WHEREAS**, the President and Board of the Village Trustees have determined it reasonable and necessary for the Village to increase refuse and recycling charges to offset the increase in cost to the Village.

**NOW, THEREFORE BE IT RESOLVED** by the President and the Board of Trustees of the Village of Bensenville, Counties of DuPage and Cook, Illinois. As follows:

**SECTION ONE:** That the recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** That the Village Board hereby authorizes rates for refuse, recycling, and yard waste be amended as of January 1, 2025, as follows:


1. Single Family: \$27.66 per unit/month
2. Single Family Senior Rate: \$23.51 per unit / month  
For a resident to be eligible for the Single-Family Senior Rate, the principal of the home must be 60 years of age, must provide proof to the Village, and request the discount.
3. Multi-family dwellings containing two (2) through five (5) units:  
Two (2) units: \$54.31/month  
Three (3) units: \$76.26/month  
Four (4) units: \$98.95/month  
Five (5) units: \$121.73/month
4. Multi-family dwellings containing six (6) units: \$24.94 per unit / month
5. Multi-family dwellings containing seven (7) through twelve (12) units: \$20.80 per unit / month.
6. Multi-family dwellings containing thirteen (13) through eighteen (18) units: \$19.98 per unit / month.

7. Multi-family dwellings containing nineteen (19) or more units: \$18.83 per unit / month.
8. Multi-family dwellings containing nineteen (19) through one hundred forty-nine (149) units with compactor service: \$17.77 per unit / month.
9. Multi-family dwellings containing one hundred fifty (150) or more units with compactor service: \$13.94 per unit / month.

**SECTION THREE:** That this Resolution shall take effect immediately upon its passage and approval as provided by law.


