I am pleased to help you with your May 6, 2025 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on May 6, 2025. You requested copies of the items indicated below:

"Checking if property 218 Blackhawk Ter, has any lines, fines, tickets, violations or water bill. We are scheduled to close 5-8-25."

After a search of Village files, the following records were found responsive to your request:

- 1) Village of Bensenville Correction Notice for Inspection No. 100438. (1 pg.)

The water account is \$44.22 past due and a new bill for \$39.13 was just generated today making it \$83.35 currently total due. We will still be billing for the 8 days of May when we generate the final bill on 5/8/25.

Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville.
